7:22 PM – Public Safety Presentation by Sergeant Matt Jacobsen with the Neighborhood Response Team, and Portland Police.

- Jacobsen presented neighborhood crime statistics. Crimes within our neighborhood have stayed about the same as in previous years.
- The Neighborhood Response Team is made up of four officers. The department is currently working with limited resources and their job is to respond to situations where an individual's life may be in danger.
- Jacobsen provided instructions to SPNA and Community for how to report incidents and possible criminal activities within our neighborhood.
- Jacobsen informed that graffiti is no longer considered vandalism, and all reporting should go to the office of graffiti abatement. Jacobsen encouraged the community to continue reporting any graffiti incidents in the neighborhood. There are multiple ways to report graffiti:

7:50 PM – Karl Dinkelspiel & Lisa Abuaf with Prosper Portland provided an update on the North Macadam Urban Renewal Budget

- Dinkelspiel provided background information about Prosper Portland and a general overview of the budget.
- Dinkelspiel provided a brief explanation of the process for small businesses to access resources
- Abuaf spoke about budget forecasting strategies and community development
- Abuaf spoke about current projects in the neighborhood and their budget
  - Community Development
  - Affordable Housing 178 Units in the South Waterfront

The SPNA decided to postpone creating a subcommittee given that the neighborhood priorities have not changed since originally were identified.

- The group continues to experience an enormous amount of frustration with the lack of communication between the city and commissioner Ryans' office.
- On-going issues with the school because the city refuses to deal with the legal ordinance of 150 feet from their properties.
